

Schedule of Accreditation



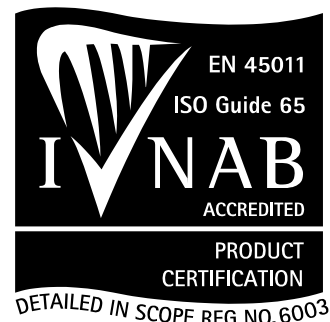
