INAB TO HOLD 5TH ASSESSOR FORUM IN 2014

On 30th January 2014, INAB will welcome national and international assessors to Dublin, where it will hold its 5th Assessor Forum. The Forum was established in 2005, with the objective of harmonising the INAB accreditation process and assessment team. Every two years the Forum is held to encourage ongoing training of our assessment teams.

Participation at the Forum ensures that active and new assessors, experts and technical experts benefit from an open platform, where new INAB policy issues are discussed and where INAB and the assessor has the opportunity to unite and work together sharing experiences.

In 2014, the Forum will focus on key changes to the standards ISO 15189, ISO 17065 and ISO 17020. A review of the current forms for reporting and the extranet which is currently being phased in on a full time basis will all be covered. INAB assessors have been asked to contribute to the day by forwarding any suggestions or areas for discussion.

INAB look forward to welcoming assessors to Dublin in 2014.



INAB UNDER THE MICROSCOPE EA PEER REVIEW 2014

In 2014, date yet to be agreed, a team of EA (European Co-operation for Accreditation) Peer Evaluators will descend on Dublin, as the week long audit of the Irish National Accreditation Board and its accreditation activities begins.



Peer Evaluation 2014

A team of approximately six persons will make up the EA Peer Review team.

The EA team will review and scrutinise INAB accreditation activities specifically laboratory and calibration testing, inspection, management systems, and product certification.

The EA Team will typically witness at least one assessment off site per standard. Time will also be spent at INAB offices evaluating files, procedures, policy and records against requirements of ISO 17011. The evaluation will last approximately 5 days.

Why is INAB subject to this Peer Review?

INAB is signatory to the EA Multilateral Agreement (MLA).

As a signatory we are subject to participate in these reviews of our activities to show our compliance with the internationally agreed standard for accreditation bodies, ISO/IEC 17011 and the specific requirements of Regulation (EC) No 765/2008.

It is extremely important to INAB to have a successful outcome, so we can remain within the EA MLA, and by extension the MLA's of the IAF and ILAC.

INAB had our last peer evaluation in 2010 and it was successful.

What is the EA Multilateral Agreement (MLA)?

The EA MLA is a signed agreement between EA accreditation body members, to recognise and accept the equivalence and reliability of their individual accreditation services and thus the certificates and reports issued by the organisations they accredit.

International markets have confidence in the EA MLA and the conformity assessment results provided by organisations accredited by EA MLA signatories.

Because of this, there is no need for products and services to be re-tested, re-calibrated, re-inspected or re-certified in each country into which they are imported and sold. This helps the free movement of goods and services in Europe and the rest of the world. EA and its National Accreditation Body members, invest considerable effort and resource in maintaining the integrity and robustness of the EA MLA.

EA MLA promotes confidence

- The process is observed by personnel from the European Commission, national authorities, and the EA Advisory Board consisting of stakeholders and other interested parties in the business and regulatory community.
- Evaluations include office-based scrutiny as well as the observation of assessor visits in order to determine that before being accredited, conformity assessment bodies are examined in sufficient depth to establish their competence, impartiality and performance capability.
- To ensure consistency, transparency and acceptability to all, the peerevaluation process is itself continuously updated to take into account the changing needs of business, regulators and national authorities. In this way, stakeholders and regulators can be assured that the National Accreditation Body's technical competence is thoroughly and appropriately evaluated.
- Outside Europe, the EA MLA is recognised by the International Laboratory Accreditation Cooperation (ILAC) and the International Accreditation Forum (IAF).

INABs participation in the peer evaluation activity ensures that INAB maintains its respected reputation in the EA and International community.

Mr Jim O'Toole Director of Meat and Livestock Division Bord Bia

Jim O'Toole has been the Director of the Meat and Livestock Division since March 2012 where he has responsibility for the provision of Bord Bia's marketing and promotion services for this sector.

He is also involved in developing Bord Bia's sustainability initiative for the Irish farming and food sector, Origin Green.

Emer Lawlor graduated MB, BCh, BAO from UCD. She specialised in haematology after graduation in the Federated Dublin Voluntary Hospitals and later in St James's Hospital Department of Haematology in both service and research posts.

She has been a consultant haematologist in the Irish Blood Transfusion Service from 1989 to October 2011 where she was Medical Director of the Irish Bone Marrow Registry from 1990, Deputy Medical Director from 1997, and Director of the National Haemovigilance Office from 1999-2010.

She was Consultant Haematologist in St James's Hospital in charge of the Department of Transfusion Medicine from 1996-2010 and Senior Lecturer in Haematology in Trinity College, Dublin.

She is a Fellow of the Royal College of Physicians of Ireland and Fellow of Royal College of Pathologists (UK) and the Faculty of Pathology, RCPI. She has an MSc in Healthcare Ethics and Law from RCSI and is also a qualified barrister.

Her interests include blood transfusion safety through investigation of near miss events and errors leading to enhancement of safe transfusion practice.



Ms Ita Kinahan State Chemist The State Laboratory

Ita Kinahan was appointed to the position of State Chemist in September 2012. As head of the State Laboratory she has overall responsibility for the management and development of the laboratory, which provides a comprehensive analytical and advisory service to government departments and offices.

Ms Kinahan joined the State Laboratory as a Chemist in 1990 and has worked in a number of roles mainly in the areas of occupational health and safety, official control of animal feeding stuffs and food safety. She was appointed as Principal Chemist in 2007 and was responsible for managing a senior team. She also acted as the laboratory's Finance Officer and as Technical Manager for the laboratory's Quality System.

Ms Kinahan completed the Graduateship of the Royal Society of Chemistry in 1987 and obtained an MSc in Instrumental Analysis from Dublin City University in 1990. She is a member of the Irish Codex Advisory Committee and represents Ireland on the Codex Alimentarius Committee for Methods of Analysis and Sampling. She has also been a member of CEN and ISO technical committees since 2001 and provides input into the standardisation of EU and international methods of analysis.

POLICY ON WITNESSING ACTIVITIES AND SCOPE MANAGEMENT FOR CERTIFICATION AND VERIFICATION BODIES

INAB has developed a policy on witnessing activities and scope management for certification and verification bodies and this has been issued as INAB policy statement PS22. The purpose of this policy statement is to ensure the consistent application of mechanisms and criteria in assessing the scopes of applicant and accredited organisations. This policy statement will also be used for surveillance purposes during the each accreditation cycle.

The policy statement primarily deals with management system certification but also covers verification and product and personnel certification. INAB PS22 is based on original source material developed by EA and other accreditation bodies and involved a consultation process with our accredited certification and verification bodies. NSAI EXTENSION TO SCOPE IN PRODUCT AND MANAGEMENT SYSTEMS

Dr Adrienne Duff, Manager of the Irish National Accreditation Board, attended the NSAI Certification Awards on 12th November 2013. At the Awards, Minister of State for Small Business, Mr John Perry T.D. presented NSAI with their updated INAB accreditation certificates which included extensions in both Product and Management systems.

Presentation of INAB Certificates to NSAI

In September, NSAI extended their product for the purposes of notification under the PEFC's Chain of Custody scheme. The Programme for the Endorsement of Forest Certification schemes (PEFC) is a mechanism for tracking certified material from the forest to the final product to ensure that the wood, wood fibre or non-wood forest produce contained in the product or product line can be traced back to certified forests. The aim of the programme is to deliver confidence to customers and the end consumers that the raw materials originate from sustainably managed forests.

In July, NSAI also extended their management systems scope of accreditation to include Construction Products Regulations (CPR).

ISO/IEC TS 17021-3 COMPETENCE REQUIREMENTS FOR AUDITING AND CERTIFICATION OF **QUALITY MANAGEMENT SYSTEMS**

The International Accreditation Forum (IAF) at its general assembly held in Seoul, South Korea, on 23rd and 25th October 2013, endorsed ISO/IEC TS 17021-3 as a normative document to be applied in conjunction with ISO/IEC 17021 for QMS.

This technical specification contains specific competence requirements for personnel involved in the certification process for quality management systems (QMS) and complements the existing requirements of ISO/ IEC 17021. INAB expects that certification bodies will prepare plans for implementation of this standard and will review progress towards implementation at assessment and surveillance visits in 2014.
