## SCHEDULE OF FEES 2015



## **INAB CLIENT SATISFACTION SURVEY 2014**

INAB distributed an online survey via email to all its accredited and applicant members in May 2014. The main objective of the survey was to ascertain our member's satisfaction with the accreditation process and service. All recipients were asked to complete the survey by the end of June 2014.

#### **Review of Respondents**

- 115 clients responded to the survey.
- 44% are clients for the ISO 15189 Medical Testing Scheme.
- 53% ISO 17025 Testing and Calibration.
- 6% represent Certification/Inspection.



#### Personnel and Service Handling

- 83% agreed INAB is easy to contact.
- 86% agreed staff are professional.
- 73% agreed INAB staff respond in a timely manner.

#### **Application Stage**

- 69% agreed sufficient information available from INAB and website.
- 65% agreed INAB was efficient at processing application.

#### **INAB Assessment Visit**

- 92% agreed purpose and nature of visit was clearly explained.
- 83% agreed visit arrangements handled efficiently and effectively.

#### **INAB** Assessment Team

- 93% agreed assessment team assessed their competence for a specific range of activities.
- 90% agreed assessment team communicated in a controlled and professional manner.
- 78% agreed the assessment team understood their business.
- 70% agreed the assessment team resolved their concerns on the day of the visit.
- 88% agreed findings were presented in a calm manner.

- 86% agreed assessor demonstrated current competence in the activity being assessed.
- 81% agreed assessment team adhered to the PS8 Code of Conduct.


#### Post Visit

- 63% agreed INAB dealt with post visit queries satisfactorily (before submission of corrective actions).
- 68% agreed assessment team handled correction actions promptly.

- 77% agreed the decision on their accreditation was promptly relayed.
- 56% agreed revised scope applications were processed in a timely manner.
- 54% agreed extension to scope applications are processed in a timely manner.

- 73% agreed findings added value and contributed to improvements.
- 83% agreed accreditation brings value to their business.
- 96% agreed achieving accreditation with INAB is a significant accomplishment.
- 51% agreed membership is money well spent.

## INAB EXTEND IAF MULTI-LATERAL AGREEMENT TO INCLUDE GLOBALG.A.P. LEVEL 4 & 5

On the 16th October, Dr Adrienne Duff, Manager of INAB accepted the IAF MLA multi-lateral agreement certificate from Randy Dougherty, IAF Chairman, at the IAF/ILAC Joint Annual Meeting in Vancouver.

This certificate outlines the extension of INABs multi-lateral agreement to include the sub-scopes:

- Level 4: GLOBALG.A.P. General Regulations, and
- Level 5: GLOBALG.A.P. Integrated Farm Assurance Control Points and Compliance Criteria.

INAB is a signatory to the IAF multi-lateral agreement (MLA) on product certification; IAF is a signatory to the MoU with FoodPLUS GmbH for accreditation of certification bodies involved in GLOBALG.A.P. certification activities.

G.A.P. stands for Good Agricultural Practice – and GLOBALG.A.P. is the worldwide standard that assures it. It is a global organisation with a crucial objective: safe, sustainable agriculture worldwide.

INAB currently has one certification body accredited that include GLOBALG.A.P. on their scope.

## INAB EXTEND SCOPE TO INCLUDE VERIFICATION

INAB have successfully undergone peer evaluation by European Co-operation for Accreditation (EA) for accreditation of verifiers as required by Article 64 of Commission Regulation (EU) No 600/2012.

INAB officially signed the agreement during the EA General Assembly held in The Hague, the Netherlands on 19th-20th November 2014.

## NEW ILAC WEBSITE



The International Laboratory Accreditation Cooperation (ILAC) launched its new website at the end of August. The new website will play an important role in the organisation's relationship with its members and stakeholders.

The website includes several new features that improve the availability of information, such as:

- A dedicated search for the signatories to the ILAC MRA.
- Consolidation of the information on the signatories to the ILAC MRA to one page.
- A specific area for regulators and users of the ILAC MRA.
- Link to the directories of accredited proficiency testing providers and reference material producers, where available, in addition to the current links to accredited laboratories and inspection bodies.

The ILAC Signatory search is now available from the INAB website. This is a dedicated search for the signatories to the ILAC multi-lateral arrangement.



## MEDICAL ADVISORY COMMITTEE

In 2010, INAB established the Medical Advisory Committee (MAC), its purpose to offer advice to the INAB Executive on issues of principal importance in accreditation to ISO 15189.

The committee has been meeting for four years and is chaired by Dr Cor de Ruiter, lead assessor and former operational manager from the Dutch Accreditation Council (RvA). The membership includes a wide spectrum of medical expertise from all relevant disciplines and end users of accreditation.

INAB would like to welcome Dr Gerard Boran, Clinical Chemistry Department, AMNCH representing the National POCT Consultative Group and Mr Chris Sharpe, Lead and Technical Assessor for four European Accreditation Bodies, Former Laboratory and Quality Manager for a University Hospital Trust in the UK.

#### MAC Task Force Groups

There are currently a number of active task force groups on the Medical Advisory Committee, with the recent addition of POCT, Point of Care Testing; and the molecular diagnostics group which will be led by Patrick Hayden with Dr Aileen Butler, Principal Clinical Molecular Geneticist at Our Lady's Children Hospital, Crumlin.

- FAQ MAC working document on ISO 15189:2012 which will be presented to the INAB Board in December 2015.
- The Chair presented a new procedure for the functioning of Task Force Groups within the MAC which was welcomed by the committee.
- INAB sought MAC input on validation/verification procedures; the committee agreed that each task force group would produce recommendations containing minimum criteria for use by laboratories for validation/verification for each discipline by our next meeting in March 2015.
- Presentations by INAB on new policy PS23 and revisions to Notification on sample handling.

Raymond Ellard Director of Consumer Protection Food Safety Authority Ireland

Raymond Ellard is the Director of Consumer Protection at the Food Safety Authority of Ireland. He has worked in various aspects of food control from the local to the international level since he qualified as environmental health officer (EHO) in Ireland in 1975. For eight years he was Chief Environmental Health Officer with the Department of Health and Children. He moved to the then newly established Food Safety Authority of Ireland (FSAI) as Chief Specialist in Environmental Health, before taking up his present post there as one of the Directors.

Currently, as the Director of Consumer Protection, he is responsible for the Authority's training group, veterinary public health group, food incident team, data collection and the Consultative Council.

He has worked with the EU systems as a national expert representing Ireland at various working groups on food safety and food regulation. He worked internationally as a consultant on food control for both the World Health Organization and the Food and Agriculture Organisation. In addition he worked as a training provider and project leader on food safety and food control for many EU candidate countries. He represents FSAI at the European Food Safety Authority's (EFSA) Advisory Forum and was chair of EFSA's Working Group on Crisis Preparedness.

For five years from 2006 he was Honorary Secretary of the International Federation of Environmental Health. He holds three Master's Degrees – one each in Food Science, Health Services Management and European Food Regulatory Affairs.

Peter Dennehy, as well as being the Director of Corporate Services, is Deputy CEO and Board Secretary at the NMBI.

Spanning 30 years, Peter has held Senior Manager positions in the Public, Private and International sectors, he is an experienced leader of Irish, UK and Worldwide organisations within technology, services, international standards and government regulatory organisations.

Peter is a graduate of Trinity College Dublin University, a Chartered Engineer, a Fellow of the Institute of Engineers Ireland and a Member of the Institute of Directors.

## INAB POLICY REVIEW AND AMENDMENTS

#### New Policy – PS23

PS23 sets out INAB Policy for both ISO/IEC 17025 testing and calibration laboratories and ISO 15189 medical testing laboratories when they are offering accredited testing/calibration services. If a laboratory is accredited for a test/calibration as defined in the laboratory's scope of accreditation, then the laboratory shall offer this test/calibration as an accredited service at all times.

In the case of medical laboratories INAB recognises and acknowledges that these laboratories may offer a reduced suite of tests (for example during out of hours or at weekends), however for this reduced suite of tests the laboratory is required to provide the same level of accredited testing service whenever the testing is being undertaken.

### Notification on sample-handling, processing and timely reporting of critical samples as per ISO 15189 requirements

This notification is a revision to the initial INAB notification on Blood Cultures issued to applicant and accredited medical testing laboratories in March 2014 and has been revised to incorporate comments and feedback obtained by INAB from a number of sources, including The Irish Society of Clinical Microbiologists, the INAB Medical Advisory committee (MAC) and the EA WG (European Accreditation Working Group) on Healthcare.

The key changes to the original notification are as follows:

- A change of the title to more accurately reflect the purpose of the notification which is related to sample handling, processing and timely reporting of critical samples as per ISO 15189 requirements.
- The notification now allows for the clinician responsible for the patient, and not the consultant microbiologist, to be informed in the event of an urgent positive result.
- The section on ISO 15189 examination procedures clause 5.5.1 stating that preferred procedures are international, national or regional guidelines has been removed as it was confusing the issue and was not central to the notification on handling and reporting of urgent samples and results in a timely manner.

Please note the three month timeframe statement in this notification (Section 4) has been removed as that applied to the March 2014 notification date and is not applicable for this revision.
