I would like to take this opportunity to bid farewell after 20 years in INAB. I joined INAB in 2002 and worked as an assessment manager for laboratories, certification and inspection bodies. In 2008, I was appointed Manager of INAB following Tom Dempsey's retirement.

It has been a hugely diverse, interesting and fast 20 years. I joined INAB when it was part of Forfás and from 2014, as an integral part of the Health and Safety Authority. The demand and recognition of accreditation has changed enormously since 2002 and accreditation plays a vital, if often unseen role, in our everyday lives, ensuring goods and services are safe and fit for purpose. When I joined INAB, the bulk of our clients were laboratories, providing testing and calibration services. Now, with 239 accreditations, the majority are still laboratories but we have grown a sizeable base of accredited certification and inspection bodies. What has changed noticeably in that time has been the sheer breath and application of accreditation; from DNA/ fingerprint analysis to cybersecurity certification to organic farming to vehicle inspections. No two client scopes are the same and it is a testament to accreditation generally and to INAB particularly that we can respond to market, regulatory and client demands.

Our recently launched <u>Strategy for Accreditation</u> will further embed accreditation into Irish enterprises, policy and legislation.

As manager, I have been fortunate to work with very committed and capable INAB staff over the years. I want to express my sincere gratitude for their support as INAB has grown and evolved. INAB itself has been greatly supported by all our colleagues in Forfás and the Authority who provide finance, ICT, corporate governance and HR expertise.

The Accreditation Board has been constant in its support for accreditation and all members over the years have given freely of their time and expertise to guide and oversee INAB accreditation. As an Accreditation Board member, I have seen first-hand how committed and engaged the members are, demonstrating an interest and belief in the value and importance of accreditation.

Within Europe, accreditation is now a strong, recognised and respected support to the single market and EU regulation. My colleagues in EA (https://european-accreditation.org) have brought this recognition for accreditation and again I want to acknowledge all the work, support and friendship from the EA community over the years.

NEWS ON LABORATORY ACCREDITATION

Accreditation of Biobanking according to ISO 20387

INAB offers accreditation of biobanks to the standard, ISO 20387:2018 and is ready to take applicants.

ISO 20387 "Biotechnology – Biobanking – general requirements for biobanks", is related to the operation of biobanks to ensure that biological material and data collections are produced and maintained appropriately.

This standard is applicable to all organisations performing biobanking, including biobanking of biological material from multicellular organisms (e.g. human, animal, fungus and plant) and microorganisms for research and development. It does not apply

to biological material intended for food/feed production, laboratories undertaking analysis for food/feed production, and/or therapeutic use.

The requirements to apply are a

- Quality system in place and operating according to ISO 20387
- Sufficient resources
- Competent staff
- Minimum activity
 (acquisition, storage and distribution)

A formal qualification procedure is in place and all applicants will be evaluated against documented criteria and current demand.
